A meeting of Academic Council was held on 20 May, 2022. The Academic Council considered the matter and the resolution given in agenda no. 17.3 is as under.

A status report was presented by the Nodal Officer, CUET. After extensive deliberation following recommendations were made-

1. The Academic Council approved the mapping of Under Graduate(UG) and Post Graduate (PG) programmes offered in university campuses and its affiliated colleges / institutions for CUET-2022.
2. As far as mapping of M.Pharm is concerned same may be done as per the norms of PCI and a notice in this regard to be uploaded in the university website.
3. It was also informed by the Registrar that as per the UGC letter No.F.13-11/2020(C U) dated 19.05.2022, admission through CUET for UG courses only for the year 2022-23 have been exempted for affiliated colleges / institutions of universities of NE hill areas including HNBGU. Accordingly, it was resolved that admissions into UG courses for affiliated colleges / institutes of HNBGU for the year 2022-23 may be done as per past practice. However, CUET for admissions into UG (all three campuses) and PG (all three campus and affiliated colleges) courses of HNBGU shall be conducted as per schedule. If any affiliated college/ institute wants to join CUET for admission into UG courses they are free to join.

The council also expressed its satisfaction and appreciation for the efforts made by the University for its awareness campaign and wide publicity of CUET-2022 as admissions shall be done through this entrance examinations for the first time.
