About The Seminar :

Mahatama Gandhi always believed that the "Future of India Lies in its villages" and he was convinced that "If the villages perish, India will perish too". For him rebuilding of the nation could be achieved only by reconstructing villages. Though urbanization is increasing and consequently proportion of rural population in total population is gradually on decline still close to seventy percent population or 743 million people, as per census 2011 live in rural areas and despite declining share of agriculture and GDP, agriculture continues to employ around half the country's total workforce and over two-thirds of the rural workforce. In other words employment pressure on agriculture is tremendous and agricultural development is key to poverty eradication process. As the country aspire to double the farmers income by 2022 the policy planner need to analyze issues related to agriculture in holistic manner.

As empirical evidences suggest the sector has to strengthen itself to face these challenges to double its income by 2022. It is a fact that public investment in agricultural infrastructure is much less than desired, the supply chains, processing facilities are underdeveloped, input prices keep on growing steadily and market links are highly inadequate. Growth of population is continually reducing the size of ownership and operational holding. Shrinking community resources, overuse of fertilizer, insecticides, and underground water in some regions of the country has resulted in intoxication of soil and other environmental problems which has serious implications not only to agricultural production but also impacting health of people.

The other issues which are interrelated to agricultural development are of increasing inequalities in rural areas. Because of reduced farm size, increasing input prices and poor marketing linkages, many small and marginal farmers are leaving agriculture. Pushed out of agriculture these people join the ranks of unskilled labour in rural and urban areas. Even

the medium and big farmers, because of poor infrastructural facilities and inadequate market linkages in many instances find agriculture non economic. The farmers producing cash crops often hit due to poor facilities. The rural indebtness has always been a serious issue in public policy concern but indebtness coupled with market failures results in serious distress resulting in loss of human life.

In recent decades, even after the implementation of various government initiatives the agriculture status in India has transformed considerably which has hindered the agriculture growth to an extent thereby affecting rural development in the country. In the present context the agriculture transformation reveals some of the issues such as the increasing income inequality between rich farmers and small and marginal farmers, broader adoption of conventional agriculture practices, change of farmers approach towards agriculture, increasing farmers distress, agriculture failure to sustain livelihood, change in cropping pattern, land ownership and utilization, increasing farmers indebtedness and poverty, shift of farmers towards non-farm sector, poor agriculture productivity and fall in agriculture income, incommensurate government policies, etc. This agriculture transformation further led by climate change and other rising issues has severely affected the sustainability of agriculture which will eventually adversely affect rural development and rural communities and their livelihood in long term.

The proposed seminar attempts to highlight this agriculture transformation in rural India and will focus on understanding its dimensions and structure and the various challenges it generates for rural development and also attempt to discuss the possibilities that could be generated through molding agriculture transformation in fruitful manner so that it could act as a catalyst for poverty eradication and overall rural development.

1973. It has a rare distinction of taking birth through a powerful popular movement during early seventies in last century. This movement symbolized the hopes and aspirations
