THE LIBRARIAN

(Under Section 9 and 17 and Statute 9)

In exercise of the powers vested in Section 28(2) of the Central Universities Act 2009 and for the purpose of implementing Section 9,17 and 9 of the Statutes, the Executive Council hereby makes the following Ordinance for appointment and other terms and conditions of Librarian in Hemwati Nandan Bahuguna Garhwal University (A Central University)

Appointment to the post of Librarian shall be by selection, after advertisement in the manner laid down by the Executive Council, and the qualifications for the post shall be as prescribed by the Executive Council on the basis of the qualifications laid down by the University Grants Commission.</p> <p>2. (a) The Librarian shall be appointed on the scale of pay prescribed by the University Grants Commission, and shall be entitled to leave, leave salary, allowances, provident fund and other benefits as prescribed by the University from time to time for the administrative staff of the University.</p> <p>(b) The University shall provide the Librarian with unfurnished residential accommodation for which rent or licence fee shall be payable at the usual rate:</p> <p>(c) The Librarian shall retire on attaining the age of sixty</p>	The ordinances are being made for the first time for the Central University

		<p>two years.</p> <p>(d) The other terms and conditions of service of the Librarian shall be such as may be specified in the contract to be signed by him.</p> <p>3. The Librarian shall work under the administrative supervision and disciplinary control of the Vice-Chancellor.</p> <p>4. In case of a vacancy in the office of the Librarian, the duties of the office for the duration of the vacancy shall be performed (in addition to his own duties) by such officer or Professor of the University as may be nominated by the Vice-Chancellor for such period as he may specify:</p> <p>Provided that in the case of the Librarian is absent on leave or duty, or is unable to perform his duties for any other cause, the Vice-Chancellor may, for the duration of such absence or inability make arrangement for the office in the same manner as in the case of a vacancy in the office or, if he so deems fit, assign the duties of the office to a suitable person holding a senior administrative position under the Librarian.</p> <p>5. (a) The Librarian shall be the administrative head of the University Library (located in any campus of the University) and shall be responsible for the general management thereof.</p> <p>(b) The Librarian shall be the Member-Secretary of the Library Committee and of the Committee of Management of the Library System of the University.</p> <p>(c) The Librarian shall exercise such other functions as may be assigned by the Ordinances and Regulations, from time to time, by the Vice-Chancellor.</p>
