Report On Citizens' Duties Awareness Programme (CDAP)

The committee decided that the final year students of the Department of Law of both Tehri and Pauri campuses of HNBGU will disseminate awareness amongst the identified school students of the region for the Constitution & Fundamental Duties when the situations will become normal related to Corona pandemic and after the reopening of the schools. However, till then, a video will be developed on the related subject by Prof. Seema Dhawan to share the same to the SCERT, Uttarakhand so that it could be disseminated to the teachers during their online training programs.

In this direction, a video was created contained a detailed and insightful analysis of the fundamental duties as prescribed in our Constitution. The link of this video was shared to State Council of Educational Research & Training (SCERT), Uttarakhand.

On our request, the video was telecasted during the training program organized by the SCERT for Science Teachers through online mode from 06/07/2020 to 10/07/2020. It was played on 10th July 2020 during which Science Teachers of class 9th and 10th were connected from 500 virtual centers of whole Uttarakhand state. It is hoped that they, in turn, would apprise their students studying in their respective schools virtually about the fundamental duties and its importance. This is the first step of the CDAP, HNBGU committee to develop awareness amongst the school personnel.
