## Coronavirus disease (COVID-19) Pandemic

**Coronavirus** disease (COVID-19) is an infectious disease caused by a newly discovered coronavirus.

Most people infected with the CDVID-19 virus will experience mild to moderate respiratory illness and recover without requiring special treatment. Older people, and those with underlying medical problems like cardiovascular disease, diabetes, chronic respiratory disease, and cancer are more likely to develop serious illness.

The best way to prevent and slow

down transmission is be well informed about the COVID-19 virus, the disease it causes

and how it spreads. Protect yourself and others from infection by washing your hands or using an alcohol based rub frequently and not touching your face.

The COVID-19 virus spreads primarily through droplets of saliva or discharge from the nose when an infected person coughs or sneezes, so it's important that you also practice respiratory etiquette (for example, by coughing into a flexed elbow).

# Social Distancing, Quarantine, and Isolation

Social distancing, also called "physical distancing," means keeping space between yourself and other people outside of your home. To practice social or physical distancing:

- Stay at least 6 feet (about 2 arms' length) from other people
- Do not gather in groups
- Stay out of crowded places and avoid mass gatherings

In addition to everyday steps to prevent COVID-19, keeping space between you and others is one of the best tools we have to avoid being exposed to this virus and slowing its spread locally and across the country and world.

Quarantine is used to keep someone who might have been exposed to COVID-19 away from others. Someone in self-quarantine stays separated from others, and they limit movement outside of their home or current place. A person may have been exposed to the virus without knowing it (for example, when traveling or out in the community), or they could have the virus without feeling symptoms. Quarantine helps limit further spread of COVID-19.

Isolation is used to separate sick people from healthy people. People who are in isolation should stay home. In the home, anyone sick should separate themselves from others by staying in a specific "sick" bedroom or space and using a different bathroom (if possible).

## NAAC Assessment & Accreditation (w.e.f. 01.01.2020)

The criteria based assessment forms the backbone of A&A process of NAAC. The following seven criteria serve as basis for assessment:

- 1. Curricular Aspects
- 2. Teaching-Learning and Evaluation
- 3. Research, Innovations and Extensinn
- 4. Infrastructure and Learning Resources
- 5. Student Support and Progression
- 6. Governance, Leadership and Management
- 7. Institutional Values and Best Practices

Under each Criterion a few Key Indicators (KIs) are identified which are further delineated as **Metrics**. The Self Study Report (SSR) to be submitted for assessment has a total of 115 Metrics covering the seven Criteria. Further, the SSR has two kinds of Metrics: (i) 'Quantitative **metrics' (Q\_M)**, those requiring quantifiable facts and figures as data and (ii) 'Qualitative metrics' (Q,M), those requiring descriptive responses.

#### Criterion II: Teaching Learning and Evaluation (200)

Criterion II pertains to the efforts of an institution to serve students of different backgrounds and abilities, through effective teaching-learning experiences. Interactive instructional techniques that engage students in higher order 'thinking' and investigation, through the use of interviews, focused group discussions, debates, projects, presentations, experiments, practicum, internship and application of ICT resources are important considerations.

It also probes into the adequacy, competence as well as the continuous professional development of the faculty who handle the programmes of study. The efficiency of the techniques used to continuously evaluate the performance of teachers and students is also a major concern of this Criterion.

# **Glossary (Teaching Learning and Evaluation)**

Advanced Learners: Students who perform very much better than the class averages.

Blended Learning: A mixing of different learning environments such as traditional face-to-face classroom methods with modern computermediated activities.

Demand Ratio: The ratio of the number of seats available in a program/ institute to the number of valid applications

**Evaluation Process and Reforms:** Assessment of learning, teaching and evaluation process and reforms to increase the efficiency and effectiveness of the system.

Faculty Development Program: Programs aimed at updating the knowledge and pedagogical skills of faculty.

Graduate Attributes: The disciplinary expertise or technical knowledge that has traditionally formed the core of most university courses. They are qualities that also prepare graduates as agents for social good in an unknown future.

**Open Educational Resources:** Educational materials and resources offered freely and openly for anyone to use and under some licenses to re-mix, improve and redistribute.

Participative Learning: Participatory Learning and Action is a family of approaches, methods, attitudes, behaviours and relationships, which enable and empower people to share, analyze and enhance their knowledge of their life and conditions, and to plan, act, monitor, evaluate and reflect.

Remedial Courses: Courses offered to academically disadvantaged students in order to help them cope with academic requirements.

Slow Learners: Students who perform very much below the class averages.

Problem Based Learning (PBL): Is a student-centred pedagogy in which students learn about a subject through the experience of solving an openended problem found in trigger material. The PBL process does not focus on problem solving with a defined solution, but it allows for the development of other desirable skills and attributes e.g. knowledge acquisition, enhanced group collaboration & communication. Student Centric Methods: Methods of instruction that focus on products of learning by the students.

## Meeting addressed by Vice-Chancellor

**On** 27<sup>th</sup> January, 2020 Hon'ble Vice-Chancellor Prof. Annpurna Nautival addressed all Deans of Schools, HoDs, faculty members, Campus Directors, Officers of the University in a meeting at ACL Hall, Birla Campus, Srinagar. Discussing the areas of concern related to teaching, research, finance and governance, she called upon all present, to get involved in the progressive activities and contribute towards overcoming the shortcomings. She said that collectively we can achieve excellence.

Prof. O.P. Gusain, Director, IQAC made a presentation on "Preparedness for 3rd Cycle NAAC Assessment and Accreditation". He informed that the University will submit the online Self Study Report (SSR) to NAAC in September this year as per the requirement. He sought active cooperation from all faculty members to update the data of the last five years.

Dr. M.S. Rana, University Li-

University Librarian informed of the progress made so far for the automation of Central Library. He also said that soon Scopus will be available for all concerned.

Prof. M.C. Nautiyal, Coordinator of RCCC informed the house that all related policy documents are ready to be submitted for approval by the Executive Council of the University.

System Manager, Mr. Sanjeev Srivastava informed that the University website is under the process of upgradation and said that the contents are yet to be updated by all concerned. Regarding campus wi-fi, he said that an intervention by University



authorities will expedite the pending issues with MHRD.

The meeting concluded with Hon'ble Vice-Chancellor expressing her belief in the capabilities of all faculty and officers to take the University to a higher NAAC grade.

A meeting of the Conveners of the IOAC Task Groups & Coordinators of the Special Cells of the University was held on 25<sup>th</sup> January, 2020. The data required for filling the 115 metrics was discussed in detail.

## Feedback from stakeholders

Since, 2015, the IQAC has been regularly obtaining feedback from the 'Students on Teachers'. Also, feedback by 'Students on Curriculum' is being obtained 2018 onwards. The students of PG and Professional programmes participate in the exercise.

Additionally, feedback is obtained from Hostellers at the end of the session.

The process of revision and redesign of curricula is based on recent developments and feedback from the stakeholders, therefore, from this session, the IQAC has introduced a feedback form for obtaining **feedback from the Teachers on Curriculum Design and Devel**- opment. The exercise aims at identifying and drawing pertinent pointers after analyses to enhance the learning effectiveness.

Feedback is obtained on the following points:

- Units in syllabus are relevant to the course.
- The contents of the course are in conformity with the learning outcomes.
- The syllabus has good balance between theory & application.
- The course/programme of studies carries sufficient number of optional papers.
- The books prescribed/ listed as reference mate-

rials are relevant and updated.

- Employability is given weightage in curriculum design and development.
- The contents of the curriculum are in tune with the UGC/ CSIR-NET/GATE/GPAT examinations.
- The curriculum has the potential in developing the habit of self learning in students.
- The curriculum has been updated in terms of demand.
- Freedom to contribute ideas on curriculum.
