In IV Semester, Course No. 22-SOACL-C-024 be treated as an Elective course which is T.V. Journalism and Production - II (Practical).






Above changes were submitted to Controller, Examination by the Convener, B.O.S. (Mass Communication) on 25-02-13 as required by him.




