


A meeting of the board of studies in physical education was held in the department of physical education at 11:00 A.M. on 14 March 2015 and the following members were present-


- 1- Prof. R.K. Shrivastava, Dean, School of Education H.N.B.G. University Srinagar Garhwal.


Following decisions were taken in the meeting-
