05% seats for economically weaker section of students have to be increased in the session 2019-2020 and 05% seats in 2020-2021. Hence committee recommends 5% increase in seats as follows:

Isha is going to complete 06 years in 18.02.2019. The matter is recommended for academic council.

8. Arun Kumar Yadav's application for Re-Registration has been considered and his progress is satisfactory hence committee recommends his re-registration.

- b. Birla Campus, Srinagar – Social Work 60 Seats

05% seats for economically weaker section of students have to be increased in the session 2019-2020 and 05% seats in 2020-2021. Hence committee recommends 5% increase in seats as follows:
