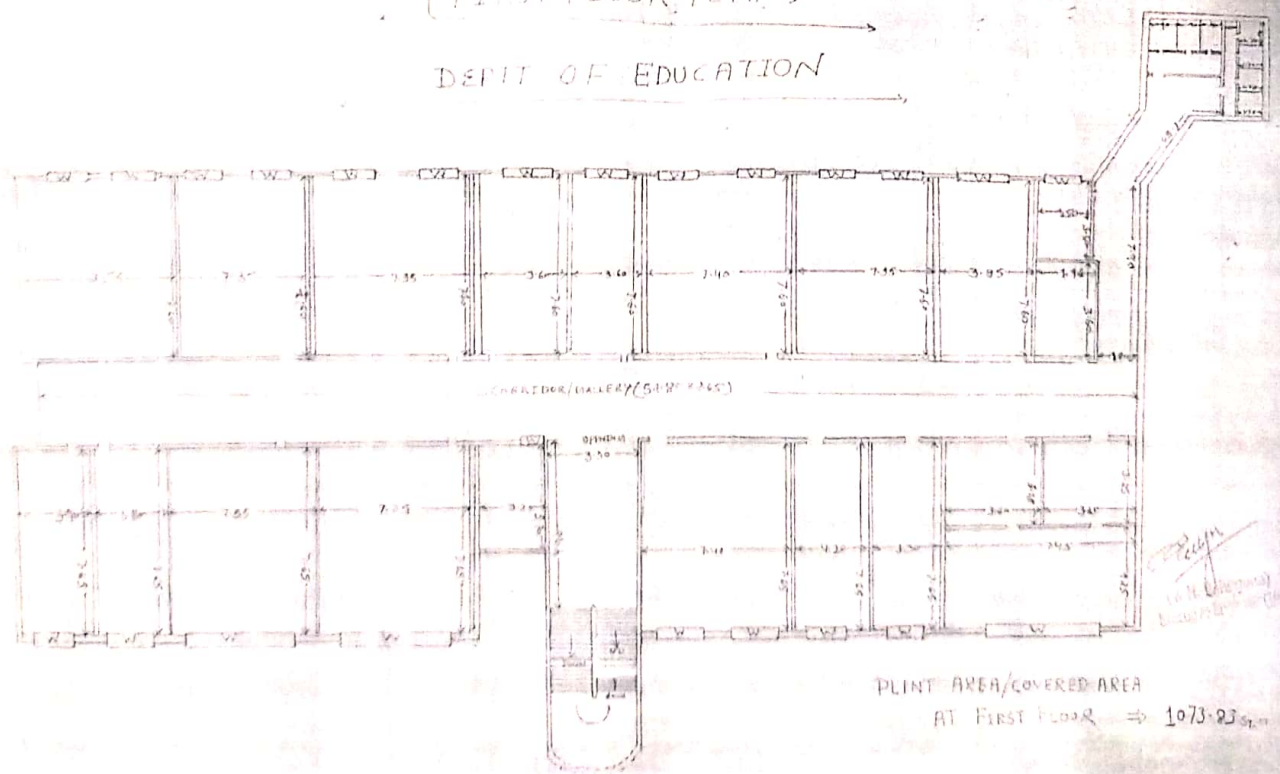

(FIRST FLOOR PLAN)

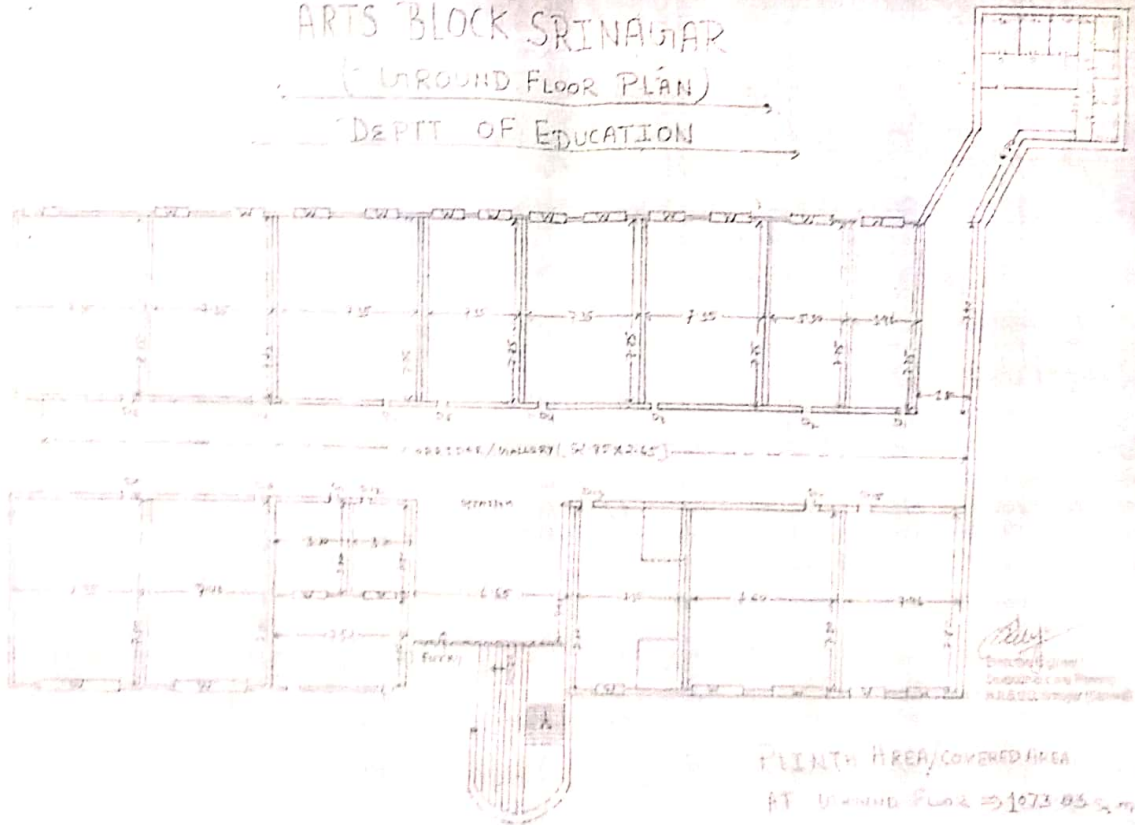

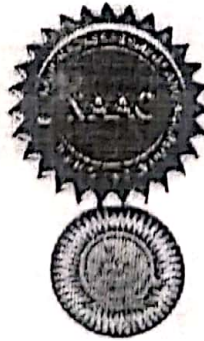
