- 2- Contractors must be Registered contractors of the PWD/CPWD/Central /State University/ state corporation Department /BSNL .
- 3- The minimum Average annual turn over should be 10 lack or more for the three financial years .
- 4- The Electrical Material supplier Contractors shall submit copy of Registration certificates in regard to PWD/CPWD/Central /State University /state corporation Department /BSNL.
- 5- The Electrical Material supplier Contractors shall submit copy of Registration certificates in regard to PAN,&GST ,Copy of income tax return of the firm for the last three years
