Agenda Item No. 14.7:

To consider punitive action/ withdrawal of affiliation against defaulter institutions affiliated with the University as per the procedure prescribed under Rule – 8 the U.G.C. (Affiliation of Colleges by Universities) Regulations, 2009.

A number of private institutions affiliated with the University are found indulged in mal practices in terms of grant of admission to the students and conduct of examinations thereupon. The examination section of the University has barred the declaration of results for such enrolments where discrepancies are revealed in terms of admission of students over and above the sanctioned seat to the affiliated institutions, admissions granted without permission of the University, conduct of examinations without permission of the University and admission granted on EWS seats without any valid proof of the same. It is also observed that upon barring declaration of the results by the University for such unlawful admissions by the institutions, the students/institutions concerned filed various writ petitions in the court. Recently, in one of such case the University Advocate advised as follows-

"The University may proceed for withdrawal of Affiliation as per the procedure prescribed in Regulation – 8 of the U.G.C. (Affiliation of Colleges by Universities) Regulations, 2009 as giving unlawful admission without due Category Certificates may amount to a conduct prejudicial to the Academic and Administrative Standards and interest of the University."

Further, the Council of the University also provided a draft letter/ show cause notice to be issued to such defaulter institutes which is enclosed herewith for consideration and approval of the Executive Council.

In the light of above, a committee is constituted vide OO. No. <u>हे.न.ब.ग.वि.वि / शैक्षणिक / 2021 / 451</u> dated 25-10-2021 to deliberate upon the issue and the committee submitted its report dated 26-10-2021 (Annexure-7, 7A, 7B) to the Hon'ble Vice Chancellor recommending withdrawal of affiliation as per rules for such institutes after approval of the competent authority.

The matter is submitted for kind consideration and further directions of the Executive Council.

Resolution 14.7:

Controller of Examination and Legal Consultant of the university presented the case in the meeting and briefed the EC about this agenda. The Executive Council deliberated on this issue and resolved that a consolidated and comprehensive list of such affiliated colleges is prepared



who are indulged in such serious breach of affiliation conditions and defy of the directions of the university. Serious view was taken by the Executive Council directing the Controller of Examinations that the list referred to above should reflect the anomalies / misdoings of each college in a tabular form so that anomalies / misdoings of each college are taken on record. Furthermore, it is resolved that show cause notice(s) to such college(s) are sent, citing their anomalies / misdoings asking as to why appropriate action(s) including de-affiliation should not be initiated against them. The committee referred hereinabove is empowered to deliberate upon the responses on a case-to-case basis, received from such colleges and is to recommend suitable action(s), if required.

Agenda Item No. 14.8:

To consider the further course of action on UGC letter No. F.13-1/2018(JCRC) dated 05th Oct, 2021 regarding service conditions of posts/incumbents of Department of Adult, Continuing Education and Extension

The Deptt. of Adult Continuing Education & Extension under School / Faculty of Education (initially started as the Adult Education Centre) is functioning at HNB Garhwal University, Srinagar and Dr. S. S. Rawat (DoJ: 19.11.1981) and Dr. A K Bahuguna (DoJ: 04.05.1984) were appointed on the posts of Project Officer in the Pay scale Rs. 700-1300 in the department. The UGC vide Letter No. F. 1-1/92 (NFE-I) dated 06-11-1995 communicated to the University that the staff working in the department / Centre for Adult Continuing Education and Extension Programmes may be treated at par with other teaching staff working in other faculties of the University. Further, the UGC issued Guidelines for Adult, Continuing Education, Extension & Field Outreach / Lifelong Learning & Extension during various Plan Periods after Xth Plan onwards for the above mentioned posts as Professor / Director, Reader / Assistant Director and Lecturer / Project Officer. Subsequently, the incumbents of the posts of Project Officer were granted the benefits of Academic Pay Scales / Grade Pay corresponding to the Teaching posts (Reader / Professor) under the Career Advancement Scheme by the University.

- 1. The University administration received a representation dated 05.06.2018 from Prof. P K Joshi, Department of Education, challenging the cadre seniority and deanship related to it by stating that the posts of the incumbents working in the Department of Adult Continuing Education & Extension does not fall into category of teaching staff.
- 2. Hence, the matter was referred by the University to the UGC for clarification vide Letter Ref. No. HNBGU/Admin/2018/1209 dated 04.07.2018. The UGC Vide Letter No. F.21-2/2016(PS/PMO/PG) dated 24th August, 2018 clarified that:
 - "......... Pay scale for Academic Staff and Colleges and University Science Instrumentation Centre should be equivalent to those of the Teachers of the corresponding levels and they should have same designation and channel of promotion provided that they have equivalent qualification."
- Another letter for clarification on service conditions of staff appointed in the Deptt. of Adult Continuing Education & Extension was sent by the University vide Letter No. RO/2018/372 dated 12.09.2018 and the UGC responded vide its letter No. F.13-1/2018(JCRC) dated 11th Sept, 2018 as follows:

B,

Therefore, as per the norms the applicable to the "Non-teaching post" the age of superannuation for the post Project Officer would be 60 years."

Measures for Maintenance of Standards, 1998 which is self- explanatory."

5. Subsequently, in response to the clarification sought by the University vide its earlier letter dated 18.01.2019, the UGC has recently responded vide its letter No. F.13-1/2018(JCRC) dated 05th Oct, 2021 wherein it has referred its earlier letter No. F.13-1/2018(JCRC) dated 11th Oct, 2018 and states that:

"............. In view of the foregoing, the Standing Committee has decided that the pay parity of the Staff of Adult Education shall not entitle them to any others benefits as admissible to teachers; and for all purposes, they shall be entitled to the benefits being admissible to the regular Non-teaching employees of the university."

In wake of above directions of the UGC, the Hon'ble Vice-chancellor constituted a committee with the Office Order No. 280/ 2021, dated 13.10.2021 (Annexure-8). The Committee after deliberation on subject matter submitted its report (Annexure-9) to the Hon'ble Vice-chancellor. Report is submitted before the Executive Council for further consideration and necessary directions.

Submitted for kind decision by the Executive Council please.

Resolution 14.8:

Executive Council deliberated on this issue and noted that university is bound to comply with the order of UGC received vide its letter No. F.13-1/2018(JCRC) dated 05thOct, 2021. The recommendations of the committee on point of reference No. 1 and 2 are accepted and approved. Accordingly, adhering to the directions of the UGC, Dr. A.K. Bahuguna shall superannuate. However, acknowledging the services he had rendered to the University and to ensure that he retires with grace it is resolved that Dr. Arun Bahuguna is to retire from the services of the university on 30thNov 2021. Dr. Arun Bahuguna is required to complete formalities related to his retirement on superannuation.

As the committee constituted in this behalf had, in their recommendation on point of reference No. 3 has recommended that "......The post-retirement benefits may be calculated and assessed by the University keeping in view of the directions of the UGC directions....." and the UGC in its letter has directed that" they shall be entitled to the benefits being admissible to the regular Non-teaching employees of the university.." hence it is resolved that all the post-retirement benefits of Dr. S.S. Rawat and Dr. Arun Bahuguna shall be that of a 'Non-teaching' employee and the salary drawn by them at their respective age of 60 yrs. shall form the basis of calculating such post-retirement benefits.

As per order no. Law College, Gopeshwar, Chamoli (Annexure -13).
