Please Note: The merit list prepared here is based on the soft copy of the documents submitted by the candidates. In case of any discrepancy found later at the time of physical verification with the originals, the admission will be cancelled and no claim shall be entertained in this regard:

These admissions are strictly PROVISIONAL and will be confirmed only after physical verification of all relevant / required documents, whenever the Campus opens for students.

1. All provisionally admitted students must produce their original documents, including High School (10th) Mark-sheet, Certificate; Intermediate (12th) Mark-sheet, Certificate; Graduation Mark-sheet; Certificate of Reservation Category (if applicable), address proof, Affidavit for gap year period (if applicable) and Anti Ragging Affidavit (as given in Prospectus).to the Admission Committee in RS&GIS Applications Department for verification. The admission to the RS&GIS Applications course will be confirmed only after the successful physical verification of documents. Also, at the time of verification, the students have to submit their original TC/CC/Migration certificate along with a signed copy of the online application form.
2. In case of the failure to produce the original documents, as described above, the admission of such candidates will stand cancelled, and the deposited fee will be reimbursed as per the university norms.
3. **Selected students have to deposit their admission/ course fee for admission to RS&GIS Applications first semester within a week after list is disclosed.** It is compulsory to deposit the admission/ course fee on or before the due time, otherwise, the candidature of such shortlisted candidates will be cancelled.
4. Online mode of fee payment will be available by signing into SAMARTH portal using their registered email id and password (<https://hnbguadmission.samarth.edu.in/>).

Candidates have to submit admission fees through online mode before the last date as notified on the website and / or in this letter, by failing which the seat will be offered to the next candidate.
