2. Candidates have to provide the original documents during physical verification of documents (High School, Inter Mark Sheets & Graduation Mark Sheets,LL.B. (3years or Integrated Course) DoB Certificate) SC, ST, OBC, EWS (if applicable) and Weightage Certificate.

The candidates have to submit one set of self-attested photocopy of all above documents and Original of Transfer Certificate (TC), Character Certificate (CC), Migration Certificate & original Police Verification (for outside Uttarakhand state candidates) and Affidavit for gap year period (if applicable) and Anti-Ragging Affidavit by the Candidate and Parent and other required documents during the physical verification process.
