# Agenda Item No. 16.11:

Sh. S.K. Sharma, who was PhD Scholar has submitted request to the university to issue him certificate from the due date of Viva. He was registered for PhD in Library & Information Science and had submitted his thesis on 18 Oct 2003 for evaluation. Meanwhile a complaint was received by the university that his thesis was not genuine. Accordingly, a committee was constituted to examine the compliant and on the recommendation of the committee, his thesis was rejected after obtaining the approval of Executive Council on 22 Sep 2008.

Sh. S.K.Sharma filed appeal in the Hon'ble High Court of Nainital in 2014. Hon'ble High Court in its judgment (Annexure-11) directed that Visitor can only take final decision in this regard whether to accept his thesis or reject the same.

Sh. S.K.Sharma again made a representation to the university in 2018. Another committee was constituted by the university to look into his request and decide. Committee found that his thesis is plagiarism free and it can be accepted by the university. Accordingly, his thesis was accepted and viva was held on 18 Jul 2020.

Now Sh. Sharma vide his application dated 13 Aug 2021 (Annexure-12) has requested to issue him a certificate and declare the date of validity regarding award of D.Phil degree from the initial date i.e. 12.04.2008 (when the very first time his viva voce examination was scheduled).

no subjects related to dental and paramedical courses are running in the university campuses. Only the examinations of such courses are being conducted by the university either on the basis of affiliation of these courses or direction of hon'ble court as per the guidelines of respective regulatory bodies. As per the 3<sup>rd</sup> amendment on 25.08.2011 of guidelines of DCI for BDS courses provided by the college –

"Any candidate who fails in one subject in an examination is permitted to go to the next higher class and appears for the said failed subject and completes it successfully before he/she is permitted to appear for the next higher examinations. However, the DCI would have no objection, if the concerned university follows their examination scheme provided in their statute/regulations."

Since no separate statute/ordinances/regulations have been framed by the University for BDS courses so far, university has to follow the guidelines of DCI. As such supplementary examination of only one subject per candidate is permissible as per the DCI guidelines.

The Petitioner institutions were also informed by the HNB Garhwal University vide letter no. Manyata/ 9277 dated 25.02.2019. Thereafter, the above paramedical, nursing and dental Colleges were also informed through reminder letter no. Manyata/Vividh/961 dated 16.12.2020 not to give admission from Session 2020-21 in case of medical, paramedical, nursing and dental courses.

The College vide letter No. CIMS&R/ADD/2020-21/1210 dated 08.08.2020 requested for "NOC" for deaffiliation from Session 2019-20 and in consideration of the request the HNBGU

issued NOC for de-affiliation vide Letter No. Manyata/909 dated 18.11.2020 and the Executive Council of the University has granted approval.

A copy of the letter No. 1900/HNBUMU/Affiliation/18-19 dated 15th January, 2018 was also sent to Vice Chancellor, HNB Garhwal University, Srinagar (Garhwal) requesting that the HNB Garhwal University should de-affiliate the above colleges at its own level.

Academic council discussed in detail on this issue and directed the university to file review appeal in Hon'ble High Court against the above said decision as stated in above agenda no. 16.17

Subsequently, Letter No. 1809/HNBUMU/Affiliation/18-19 dated 17<sup>th</sup> December, 2018 and letter No. 1900/HNBUMU/Affiliation/19-20 dated 15<sup>th</sup> January, 2019 was also received from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun.

The HNB Garhwal University, Srinagar informed the concerned Paramedical, Nursing and Dental Colleges individually, for further necessary action as per letters received from Hemvati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun.

The Petitioner institutions were also informed by the HNB Garhwal University vide letter no. Manyata/ 9277 dated 25.02.2019. Thereafter, the above paramedical, nursing and dental Colleges were also informed through reminder letter no. Manyata/Vividh/961 dated 16.12.2020 not to give admission from Session 2020-21 in case of medical, paramedical, nursing and dental courses.

The Sai Institute of Paramedical & Applied Science, Dehradun filed Writ Petition No. 429 of 2021 (M/S) before the Hon'ble High Court of Uttarakhand. The Hon'ble Court in its Order dated 17.08.2021 directed the respondents (HNBGU) to declare the result of the students for the said academic years.

A writ of mandamus was issued by the Hon'ble Court to the respondent no. 2 (the HNB Garhwal University) to declare the result of the students for the academic years 2019-20 and 2020-21.

The HNBGU sought legal opinion on the matter in order to proceed further on the issue. As per the legal opinion, the proposal is hereby submitted for kind consideration and ratification of the Executive Council.

In the legal opinion Dr. Kartikeya Hari Gupta, Advocate (counsel for the university) opined that:



"Hon'ble Court has not provided any timeline for such declaration of result of Session 2020-21 hence; it is natural that such result may be declared after students' enrolment and other due examination procedures. However, it is humbly requested that to comply the Hon'ble Courts' Orders in letter and spirit and looking at the interest of students, the above mentioned may be done on an expeditious basis.

Hence, there is no need of filing Modification Application in the present circumstances."

The request of the college along with the orders of Hon'ble High Court and legal opinion on the matter are hereby submitted for kind consideration and directions of the Academic Council.
