NOTIFICATION

In partial modification of the earlier Office Order No. HNBGU/R.O./2019/368 dated 5th August 2019 and Office Order Ref, No. HNBGU/R.O./390 dated 19.08.2019 regarding number of seats under EWS category, it is to clarify that as per Letter No. 20013/1/2018 - BC-II dated 17.01.2019 the Deptt. of Higher Education, Min. of Education (erstwhile MHRD), Govt. of India 10% admission in the universities / colleges is applicable to the candidates of Economically Weaker Sections (EWS) in addition to the reservation for the SC, ST and OBC candidates. The students may be admitted up to 10% under EWS category strictly as per directions of Director (I/c), Higher Education, Govt. of Uttarakhand Letter No. Degree Seva/Vividh/3728 dated 31.07.2019, in addition to the sanctioned number of seats and in view of the Ministry of Education / UGC and State Govt. Notification regarding reservation of seats under EWS categories. The State Govt. G.O. No. 3728 dated 31.07.2019 is applicable to **all the state universities, government colleges and aided private colleges only.**

In this connection, the University invited applications with requisite fee from the colleges / institutions for session 2020-21 and 2021-22 through on-line affiliation portal, and concerned colleges / institutes have already been intimated through individual letters after approval of the Competent Authority.

Therefore, all the concerned government / aided colleges are hereby requested to strictly check their eligibility as per directions of the Min. of Education / UGC and the State Govt. letters issued from time to time regarding the eligibility criteria, number of seats and the reservation norms etc. before grant of admission along with verification of the relevant certificates at their level in order to avoid complications at the later stage. For any ambiguity or non-compliance of the instructions of the MoE/UGC or admission in contradiction of the directions of the State Govt. regulations, the concerned colleges / institutions will be solely responsible.

It is further requested that all such govt. colleges / aided private colleges should send the details of seat allocation under various reserved categories including the seat allocations for EWS, **within 15 days of release of this notification.** The delays in submission of information by the concerned colleges/ institutions will not be entertained by the university.
