The 20<sup>th</sup> Meeting of the Executive Council of Hemwati Nandan Bahuguna Garhwal University, Srinagar Garhwal is convened in blended mode on Saturday, October 22, 2022 at 12:00 noon onwards in the Conference Hall of Hotel Inderlok, 29, Rajpur Road, Dehradun to deliberate on the agenda circulated earlier and to take decisions on the agenda items.

Ms. Bachendri Pal and Dr. B.P. Chamola, HNBGU could not attend the meeting.

At the outset, the Chairperson welcomed all the distinguished members of the Executive Council and expressed special gratitude to the external and internal members for participating in the meeting being held in the hybrid mode.

The Chairperson appraised the Council with the progress report of the University, in general; and socio-research assignments undertaken by the University. Tasks accomplished by the Consortium of Indian Himalayan Central Universities (IHCUC of 13 universities of Indian Himalayan Region and one CSIR-IHBT Palampur) being led by the HNBGU with the patronage of the NITI AAYOG, Ministry of Education, Government of India and funded by the University Grants Commission, New Delhi were appraised to the esteemed members of the Executive Council. The council members were also informed about implementation of NEP from the 2022-23 academic session and initiation of Dr. Ambedkar Centre of Excellence, and other achievements of the university during 2021-22 sessions. Specialized Training Programmes aimed towards induction of Lok-sanskriti by the Centre of Folk Performing Arts and Culture, Ganga Guide training conducted by the Centre of Mountain Tourism & Hospitality Studies under the aegis of Namami Gange Mission and agro-herbal plantation drive and training programmes by the School of Agriculture Science were reported to the Council specifically. Besides the trial of groundnut crop which has been initiated for the first time by the department of Seed Science under the direction of Dr. Prakash Nautiyal (our Alumnus) in collaboration with ICAR Junagarh and other out-reach or Lab-to-Land Programme focused on reverse-migration of native population and





development of mixed forest over 10 Acres of land with extensive plantation of saplings by the High Altitude Plant Physiology & Research Centre were also reported to the Executive council. The Council members appreciated the efforts undertaken by the University.

The Registrar, Secretary of the Executive Council, requested the members for their guidance and contribution for smooth functioning of the university, in general; and overall affairs of the university including academic/administrative and other matters, in particular.

**20.7** 375 of 2022, 376 of 22 and 378 of 2022

Dr Kailash Chandra Petwal, Dr Umrao Singh Negi and Dr Shankar Lal (all faculties of department of mathematics), HNBGU had filed Writ petition(s) numbered as 375 of 2022, 376 of 2022 and 378 of 2022, respectively, before the Hon'ble High Court of Uttarakhand. The petitioners, aforementioned, were granted promotion(s) in compliance of the resolution of Executive Council dated 28-10-2021.

The petitioners have assailed the aforementioned resolution in as much as that they have claimed that they are entitled for promotion from the date of their minimum eligibility and not from the date of their joining which was granted to them unanimously by the duly constituted selection committee for their CAS promotions.

The matter was taken up by the Hon'ble High Court. The Hon'ble High Court of Uttarakhand vide order dated 15-09-2022 while disposing of the writ petitions has directed the university to reconsider the claim of the petitioners and has also directed that if the claim of the petitioners is not agreeable, a reasoned speaking order regarding the same to be passed and communicated to the petitioners.

In compliance to above order dated 15-09-2022 the respondents in above mentioned writ petition deliberated upon the representation dated 29-09-2022 of the petitioners on 14-10-2022 and recommended that matter may be put up before the Executive Council for reconsideration the claim of the petitioners as per order dated 15-09-2022 passed by the Hon'ble High Court of Uttarakhand.

**Resolution:**

The Council discussed and deliberated on subject matter extensively. It is observed that on the recommendations dated 27-09-21 of a validly constituted Selection Committee, Dr. Kailash Chand Petwal, Dr. Umrao Singh Negi and Dr. Shankar Lal were granted promotions by the Executive Council in its meeting dt. 28-10-2021. The recommendations dated 27-09-2021 made by the then selection committee were again placed before the Executive Council. The selection committee in its recommendation had noted the following

*"....As per below standard research publications produced by the applicant and poor performance in the interview, the overall performance of the applicant is marginal. However, considering long services and other academic assignments performed, the committee recommends promotion to the post of Associate Professor from the date of joining on the promoted post..."*

Thus, the selection committee in its wisdom found that the standard of research publication(s) of the applicants was not 'up to the mark' and that the applicants had also failed to perform 'fairly well' in the interview. The Hon'ble High Court of Uttarakhand vide orders dated 15-09-2022 passed in writ No(s). 375 of 2022, 376 of 2022 and 378 of 2022 has directed the university to reconsider the claim of the petitioners and has also directed that if the claim of the petitioners is not agreeable, a reasoned speaking order regarding the same to be passed and communicated to the petitioners. The Executive Council had relied upon the recommendations of the Selection Committee and had resolved that the effective





date of promotion shall be the date of their joining on the post. As the quality of research publications is a subject matter to be assessed by appropriate experts, it would be appropriate that the qualities of research papers / publications presented by the applicants are re-assessed by external experts, again.

Therefore, the Executive Council resolved that the research publications submitted by the applicants for considering their respective promotion(s) be sent to external experts requesting them to opine on the same, on a very early note. The Executive Council further resolved that the Vice-Chancellor is authorized to nominate 3 experts (other than the experts nominated in the Selection Committee dt. 27-09-2021) to assess the quality of research publications of the applicants. It is further resolved that the opinion of such experts shall be presented before the Executive Council by way of circulation so that a reasoned speaking order is passed in compliance of orders dated 15-09-2022 passed by the Hon'ble High Court.

The university notified and directed the concerned colleges / institutes to apply for extension of temporary affiliation vide Notification No. HNBGU/Manyata/2022/737 dated 19.04.2022 and subsequent Notification No. 829 dated 24.05.2022 and they were asked to submit the relevant information through on-line affiliation portal for Sessions 2022-23 by the last date 04.06.2022, to continue affiliation of the courses with prescribed fee of Rs. 5000/- per course. In response to the notification, applications along with



requisite fee were received by the university from 81 colleges / institutions.

1. Inspection Committees were constituted for each college for surprise inspection of the colleges / institutions for Session 2022-23. During the surprise inspection certain deficiencies were observed by the inspection committees and the colleges were given 21 days' time to complete the deficiencies observed / suggested by the inspection committee. The concerned colleges / institutions have been asked to submit action taken report within one week. An appropriate action as per provisions under affiliation rules may be taken by the university against the colleges in case of non-completion / non-compliance of the formalities / deficiencies observed by the inspection Committee.
2. Similarly, the deficiencies observed by the Inspection Committees which conducted the surprise inspection of the colleges / institutions for Session 2022-23, may be treated for Session 2021-22 also, except for the colleges / courses which were granted NOC by the HN BGU for their de-affiliation from Session 2021-22. The concerned colleges / institutions may be asked to submit action taken report within one week. An appropriate action as per provisions under affiliation rules may be taken by the university against the colleges in case of non-completion / non-compliance of the formalities / deficiencies observed by the inspection Committee.

*".... In view of the matter, the writ petition is allowed. A Writ of Certiorari is issued. Impugned orders dated 25.03.2022 and 07.02.2022 passed by respondent no. 1 are hereby quashed. Respondent No. 1 is directed to allow the petitioners institute to take 100 students in B.Ed course for the academic year 2021-22 (Academic Session 2021-23) and also allow the students to appear in the examination scheduled to be held on 15.09.2022."*

In view of the directions of the Hon'ble High Court the college was allowed for 100 seats in B.Ed course for the academic year 2021-22 (Academic Session 2021-23) vide Letter No. HNBGU/Manyata/2022/1311 dated 13.09.2022, with a copy to the Controller of Examinations, for necessary action.
