The final spot counseling based on performance in CUET(UG)-2022 will be conducted by the H.N.B. Garhwal University Srinagar (Garhwal) (A Central University). You have to ensure your presence in person at School of Engineering & Technology, Chauras Campus, H.N.B. Garhwal University Srinagar (Garhwal) for reporting and counseling as per the given date and time. Candidates are further required to bring all your testimonials/certificates/documents in original and one set of attested photocopy on the reporting date.

The following documents must be produced at the time of Counseling:

1. One printed copy of online application form, filled by you generated through SAMARTH portal.
2. High School Certificate as a proof of age.
3. Mark sheet of Qualifying Examination Intermediate/10+2.
4. Category Certificate for SC/ST/OBC*/ EWS or any Sub category, issued by competent authority.

*OBC certificate must be issued after 31.03.2022 and in Central Govt. format.

Note:

1. Seat allotted to candidates in merit list first, second, third, fourth and first spot counseling may also participate in final spot counseling for the Up gradation of their branch, if they have registered for more than one branch.
2. All candidates those who are already registered on <https://hnbguet.samarth.edu.in/> may participate in final spot counseling.
3. Those who have registered on <https://hnbguet.samarth.edu.in/> on dated 5th & 6th November 2022 will be considered for the admission after exhausting previously registered list of candidates.


The counseling shall be strictly based on the **normalized score (NTA Score)** of CUET (UG)-2022 merit. If offered admission, the candidate has to take admission by **November 16, 2022** by filling up a prescribed Admission Form and by depositing tuition and other fee, failing which admission offer to him/her will be treated cancelled and the seat will be offered to the next candidate in the merit list. The candidate may note that this letter is only for spot counseling and it does not give any guarantee for admission. The admission will be subject to the availability of the seats in the respective categories and fulfillment of the eligibility criteria. The course fee of the B.Tech course is Rs. 22000/- (Rs. Twenty two thousand only) per year, the campus/college fee is Rs. 950/- (Rs. Nine hundred fifty only) per year and Rs. 5000/- (Rs. Five thousand only) as a one time caution money (refundable).

As notified in the prospectus the university cannot guarantee to provide Hostel Accommodation to all the students admitted to above mentioned programme. No students admitted to University can claim the hostel seat as the matter of right. If hostel seat is allotted, the students have to pay the fee and other charges of the hostel separately in addition to the tuition fee and others as stated above. Candidates are also advised to make arrangement to stay one day more in case counseling continues late at night. **Once again, it is to remind you that the above mentioned certificates/documents must be presented at the time of reporting failing which your candidature will be cancelled automatically.**
