The last date for fees submission is 05.12.2022.

Please Note: - The merit list is prepared based on the basis of the physical counseling held in Department of Law, SRT Campus, Badshahithaul. In case any discrepancy found later at the time of physical verification with original documents, the admission will be cancelled and NO claim shall be entertained in this regard and their seat will be allotted to the next candidate in the waiting list.

1. These admissions are **strictly provisional** & physical verification of all original relevant documents are required at the time of admission.
2. Candidates have to provide the original documents during physical verification of documents i.e. High School, Inter Mark Sheets & Law (3 Years or Integrated Law Course) Mark Sheets, Date of Birth Certificate, SC, ST, OBC, EWS (if applicable) and Weightage Certificate (if applicable).
3. The candidates have to submit one set of self-attested photocopy of all above documents and Original of Transfer Certificate (TC), Character Certificate (CC), Migration Certificate & original Police Verification (for outside Uttarakhand state candidates), Affidavit for gap year period (if applicable), Anti-Ragging Affidavit by the candidate and parent, Social Media Form, HNBGU Registration form, Registration fee receipt and Admission fee receipt by the Candidate and other required documents during the physical verification process.
