- 2. The merit list is based on the score obtained in CUET and documents uploaded to the admission portal.
- 3. All admitted students must produce their original documents (X, XII, UG Marks sheets, Category Certificate (if applicable), valid CUET score card, or any other documents as applicable, to the admission committee for the verification. The admission to MBA will confirm only after successful **physical verification** of documents. Also at the time of verification the students have to submit their original TC/CC/Migration certificate, Affidavit for gap year period (if applicable) and Anti Ragging Affidavit (as given in Prospectus) along with the signed copy of the online application. Moreover, the candidates are requested to verify their testimonials physically on or before **06.12.2022** at Department of Business Management, Chauras Campus.
- 4. In case of failure to produce the original documents, as described above, the admission of such candidates will stand cancelled, and the deposited fee will be reimbursed as per the university norms.
- 5. The eligibility criterion for MBA is as follows: Passed Bachelor Degree of minimum 3 years duration in any discipline with at least 50% marks (45% in case of candidates belonging to reserved category).
- 6. The last date to deposit the admission/course fee online for admission to MBA Program is **December 3, 2022**. It is compulsoryto deposit the admission fee on or before the due date failing which the candidature of such shortlisted candidates will be cancelled.
- 7. All the shortlisted candidates can log onto the university admission portal using their registered ID and password and deposit the fee to complete their admission process up to **03.12.2022**.
