The minutes of BOS held on 18th December 2017 were confirmed.

Item-02: To suggest a panel of 10 experts in Tourism and Hospitality Management

Proceedings: The committee unanimously purposed a panel of 10 experts on the subject and authorized the convener to hand over the list of experts in a sealed envelope to Registrar

Item-3: To discuss the issue of female faculty member participation in the field study tour conducted for the students of MBA and PGDTH students

Proceeding: The committee considered the issue and discussed the constraints and compulsions of a single female faculty member working in the department as evident by her application. In view of this, the committee unanimously decided to apprise the parents of all female students and obtain No Objection Clearance for all concerned about the tour being coordinated without female faculty participation. However it was decided to make suitable arrangement of female faculty provisions in the next year study tours.

Item-4: Consideration of the application of Dr. A. Suresh Babu for issuing of certificate and verify his Ph.D. degree as per the conditions laid down in UGC regulation on minimum qualification for appointment of teacher and another academic staff in universities and colleges and measures for the maintenance of standard in higher education (3rd or 4th Amendment).

Proceedings: With compliance of the above notification, the Board of Studies examined the application of Dr. A. Suresh Babu for the issuance of certificate for their Ph.D. Degree in accordance with the conditions laid down in UGC regulation on Minimum Qualification for appointment of Teacher and other academic staff in Universities and Colleges and measures for Maintenance of Standards in Higher Education (4th Amendment, 11 July, 2016). The Board of Studies found the credentials of Dr. A. Suresh Babu in accordance to the UGC Regulation 2016 for the issuance of Ph.D. Certificates.

Item-5: To make the provisions of field study tour for one year PG diploma students in 2nd semester.

Proceedings: The committee unanimously agreed upon the provisions of field study tour in the 2nd semester of PGDTH students for 7-8 days duration to any tourist circuit useful for their professional growth and placement. However such tour shall be organized during such periods convenient to the department.

Items-6: One year extension for thesis submission to Mr. Abhishek Vaishnava and Mr. Abhishek Mourya enrolled under professor S.K.Gupta and the evaluation of their progress report of 2017-18

Proceedings: The committee evaluated the annual progress report of both the scholars for the period of 2017-2018 and found the reports of both of them satisfactory. The committee further recommended one year extension to both Mr. Abhishek Vaishnava and Mr. Abhishek Mourya w.e.f, from 6th March 2018 and 10th March 2018 onwards respectively.

Items-7: A provision of 7 days field study tour in Bachelor of Hotel Management 1st year.

- A) If the title and contents of SWAYAM MOOC programme(s) is/are similar to any of the module(s) prescribed in the syllabi of the ongoing Degree and Diploma courses by more than 80 %, then it can be offered to the students during that semester period only for credit distribution (20% of the allotted credits in concern semester). The BOS will be the competent body to decide the similarity of the contents and title of a SWAYAM MOOC programme adopted by any student in place of any module prescribed in the syllabus in a specific semester.

of Degree and Diploma courses . A student, interested to complete SWAYAM MOOC programme(s) has to request the Director in writing in the beginning of the academic session of a semester in order to get it approved through the BOS

B) If the syllabus of a specific SWAYAM MOOC programme opted by a student matches with the prescribed syllabus of the degree and diploma semester programme more than 80 % in which the concern student is enrolled , in such situation the university decision on credit transfer shall be acceptable to the student (for example completing a SWAYAM MOOC programme of 4 credits for a similar course of 6 credit prescribed in the syllabus of offered degree and diploma courses , concern student will be awarded 6 credits against the SWAYAM MOOC programme of 4 credits or in a similar way if a student opts a SWAYAM MOOC programme of 4 credits for a course prescribed in the syllabus of offered degree and diploma courses with 3 or 2 credits, the student will be awarded 3 or 2 credits respectively for studying the SWAYAM MOOC programme in the concerned semester examination).

C) If a student successfully completes any programme(s) of SWAYAM MOOCs and such nature of SWAYAM MOOC programme is not prescribed in the syllabus of the offered degree and diploma courses in which the concern student was enrolled, in such situation no credit will be awarded to the concerned student for completing SWAYAM MOOC programme. However the name of the SWAYAM MOOC programme , completed by the student concern during the semester period will appear in the mark sheet of the concerned semester as **passed** provided SWAYAM MOOC module/Programme seems relevant to the said degree or diploma Programme. The BOS will be the competent body to decide the importance of such SWAYAM MOOC programme(s)

D) Board unanimously recommends to introduce SWAYAM MOOC module titled "Academic Writing" developed by Dr Ajay Semalty of HNB Garhwal University in MBA(TTM) third semester as a self-study course in place of existing self study course on "Eco Tourism :Principles and Practices". Each enrolled student is required to obtain qualifying marks in the written examination and no credit will be offered to the enrolled student for qualifying the paper in the semester examination as applicable in the other self study courses of the university prescribed in PG classes.






