## **Minutes of the 25<sup>th</sup> Meeting of the Executive Council November 04, 2023 (Saturday) (Online Mode)**

<p><b>Agenda Item No. 25.9</b></p>	<p><b>To consider the resignation of Dr. Aparna Raturi, Assistant Professor, Department of Biotechnology</b></p>
	<p>Dr. Aparna Raturi was working as Asstt. Professor in the Department of Biotechnology on regular basis. On the request of Dr. Aparna Raturi, Asstt. Professor and recommendation of concerned HoD and Dean, she was sanctioned Child Care Leave (CCL) for 136 days w.e.f. 6.8.2018 to 19.12.2018 vide university O/o- No. HNBGU/Admin(T)/2018/1334 dated 27.08.2018. However, on completion of her sanctioned leave, Dr. Raturi did not joined back her duties in the department. Accordingly, the concerned HoD had issued a show cause letter to Dr. Raturi for unauthorized leave of absence from duty in the month of Feb, 2019. The HoD, had informed the university administration that, Dr. Raturi had neither joined back her duties nor submitted any written explanation in response to the show cause issued by the HoD. Taking into cognizance of the letter of HoD, on the approval of competent authority, the University had issued another show case notice to Dr. Aparna Raturi, Asstt. Professor seeking explanation for unauthorized absence from duty and to joined back her duties within one week. On the basis of the information from the HoD regarding non-receipt of any information from Dr. Aparna Raturi, Asstt. Professor, the university had issued another show cause notice to Dr. Raturi, informing her to join back her duties with a written explanation for unauthorized absence from duty within 15 days otherwise submit her resignation and in case non-receipt of any information Dr. Raturi may be terminated from the university services. In response to the above show cause, Dr. Aparna Raturi, Asstt. Professor had submitted her resignation from the post of Assistant Professor w.e.f 16.04.2021 and requested to relieve her and with the release all her payments from the University.</p> <p>Dr. Aparna Raturi, Assistant Professor was on CCL w.e.f. 6.8.2018 to 19.12.2018 and she has not joined back her duties after completion of her duly sanctioned leave. Moreover, the salary for the period of CCL was also paid to Dr. Raturi. In view of this, as per the advice of Finance Section and approval of the competent authority, the university has issued a letter to Dr. Raturi that her resignation can be accepted from 6.08.2018 i.e the date from which she had proceeded on leave and she has to refund the salary (Rs. 3,63,875/-) paid for the duration of CCL. In continuation to above, again a reminder letter was issued to Dr. Aparna Raturi to deposit the amount (Rs. 3,63,875/-) paid to her on account of her salary for the leave period. Within 15 days otherwise, legal action shall be taken against her as per rule. As per the direction of the competent authority, a legal opinion was obtained from the Legal Consultant of the university. Professors and 5 posts of Adjunct Faculty (Yoga Teacher/ Therapist/ Instructor) for 1st year vide its letter No. F.NO.6-4/2016(CU) dated 28 Feb, 2017 along with approval of additional funds under salary/recurring /non-recurring for 5 years. As per the approval of the competent authority, the university had advertised the above positions on "Tenure Basis" vide HNBGU/Rect(T)/2019/02 dated 22.08.2019. Against this advertisement, as per the recommendation of selection committee and approval of the Executive Council following faculty members were appointed on Tenure Basis-</p> <ol style="list-style-type: none"> <li>1. Dr. Anuja Rawat, Associate Professor (UR) (Acad. Pay Level- 13A of UGC)</li> <li>2. Dr. Rajni Nautiyal, Assistant Professor (UR) (Acad. Pay Level- 10 of UGC)</li> <li>3. Dr. Kiran Verma, Assistant Professor (SC) (Acad. Pay Level- 10 of UGC)</li> </ol> <p>Accordingly, the persons mentioned above accepted the offer of tenure appointment and joined the university services. Afterward, these faculty members were also granted clearance of probation period as per recommendations made by the committee constituted for examining probation of newly recruited faculty members. The above faculty members have requested to provide other service benefits like regular faculty members of the university. In their representation, it is also mentioned that other Universities like Indira Gandhi National Tribal University and Central University of Rajasthan have advertised and appointed faculty members for the said scheme on regular mode. The university has already requested UGC vide its letter no. HNBGU/Admin(T)/2021/315/ dated 27.09.2021 seeking clarification regarding regularization of these posts. In response to the University letter, UGC has directed the university to send detailed proposal to MoE vide its letter No. F.No.-6-4/2016(CU) dated 28.02.2022. Accordingly, the university has already sent a detailed proposal to the Joint Secretary, Department of Higher Education, Ministry of Education, Govt. of India, New Delhi vide its letter no GU/Admin(T)/2022/749 dated 14.10.2022. 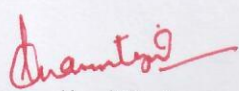
<p><b>Agenda No. 25.11</b></p>	<p><b>To consider the contribution of sports fee from all campuses/ affiliated aided colleges and institutes of the University as recommended by the Sports Council of the University in its Annual General Meeting 2023-24</b></p> <p>The Annual General Meeting for the Sports Council of the university for the academic year 2023-24 took place on September 23, 2023. As per the decision recorded in Item No. 10(1) of the meeting minutes, all campuses/affiliated aided colleges shall pay 10% and all affiliated private institutes shall pay 20% of the sports fee per academic session to the University. A copy of the minutes of the Annual General Meeting for the Sports Council of the university is placed at Annexure-11. <p><b>Agenda No. 25.12</b></p>	<p><b>To consider and approve the purchase of land in the possession of the University since 1980</b></p> <p>For the establishment of the University campus at Chauras, Tehri Garhwal, the University purchased land from local landholders, (village Madi &amp; Sankron) and one of the plot No-393, at Village- Sankron, Patti- Chauras, Tehri Garhwal is left for purchase but the University constructed approach road on the said plot. The owners of the land are claiming compensation for the said land, else noticing the University to vacate the land. Since the plot is being used for road, it cannot be vacated as of now. The area of the land occupied by the University for road in this plot is measuring to 10.5 X 9.0 Mtr =94.50square Mtr, which required to be purchased from the landholders mentioned in the revenue record. The concerned persons are willing to sale the land on existing circle rate. For the peaceful solution of the matter between the parties, the procurement is only available option which University needs to follow. The circle rates varies from time to time and as per the circle rate dated 11.08.2021, an amount of Rs. 1,50,000/-[ one lac, Fifty thousand] including MALIYAT and REGISTRY etc. will be incurred approximately on procuring the subject land. The payment may be done from development account. In context to the comments of legal consultants of the University, this is to apprise that this is the matter of procurement of land and not of the transfer of property and hence same is being submitted for approval of the competent authority. Dobriyal, Dean School of Life Sciences and member of the Council apprised the Council that due to dual responsibilities being shared by the Statutory Officers of the University, difficulties are being faced in effective management of the official works, therefore, the Executive Council shall deliberate upon the issue.</p> <p>The Council discussed the matter extensively, and it is noticed that the present Pro Vice-Chancellor Prof. R.C. Bhatt who has been appointed by the Executive Council on the post of Pro Vice-Chancellor as per provisions of Central University Act- 2009 is dispensing additional duties as Professor of the Department of History and Archaeology, H.N.B.
