The fellowship will be paid up to a maximum period of five years or the date of submission of dissertation, whichever is earlier. Further, the payment of fellowship shall be regulated in accordance with para 5.4.1 of the guidelines.

- 3. The provisional selection is subject to the condition that the awardee has already joined regular and full time Ph.D. course in a University/Institution covered under the Scheme Guidelines as mentioned in Para no. 2.4, while applying for the fellowship, and other conditions of the scheme and stipulations mentioned in this letter.
- 4. The awardee is required to produce original certificates including Bank Pass book to the respective University/Institute for verification and linking at https://scholarship.canarabank.in. The linking process should be completed on or before 31st July 2023 by the concerned university/Institute. Failure to link in the Canara Bank portal before the specified timeline will render this award cancelled. The awardee's Bank Account should be Aadhaar linked, Email id, phone number and Bank Account number of awardees should remain unchanged during the entire period of fellowship.
- 5. The award is liable to be cancelled and appropriate legal action will be taken against the awardee in the following cases:
 - a. If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
 - b. Misconduct.
 - c. Unsatisfactory progress of research work.
 - d. Fellowship/Scholarship was availed for the same/similar course from this Ministry on earlier occasion.
 - e. Availing Fellowship/Scholarship from other Schemes of this Ministry or from any other source.
 - f. Concealment of facts/material document.
- 6. The student details are required to be verified and updated at Canara Bank portal (https://scholarship.canarabank.in/) by the University.
