

Resolution: The members were agreed that one paper with two part A: Research Methodology & B: Publication Ethics in core course of Pre-PhD (Enclosed as Annexure-II).

Agenda item no.4: Revision and approval of essential qualification for the recruitment of Assistant Professor, Associate Professor and Professor in upcoming recruitment in the Forestry and mentioning specialization in M.Sc. Mark sheets/degree.

Resolution: Forestry as a discipline has dual governing authorities at national level- Indian Council of Agricultural Research (ICAR) and Indian Council of Forestry Research and Education (ICFRE). B.Sc Forestry (Hons.) has been recognized by ICAR as a professional degree (similar to B.Sc. Agri. and B.Tech. degrees) and in majority of agricultural universities it exists either as a separate Faculty (School) or Faculty (School) along with Horticulture. B.Sc. (Hons) Forestry syllabus is also framed by ICAR.

ICFRE takes care of M.Sc. Forestry syllabus. Forestry outside Indian Agricultural Universities is restricted only to 5-6 Universities/Institutes. All of them generally follow ICAR rules and regulations.

ICAR has recognized five specializations in Forestry:- Silviculture and Agroforestry, Product and Utilization, Forest Biology and Tree Improvement, Natural Resource Management, Wildlife Sciences and the M.Sc. degree awarded as M.Sc. Forestry (with Specialization).

For jobs at ICAR institutes/ Agricultural Universities, candidates should have 4 years Forestry Degree + 2 years M.Sc. degree with specialization in required field. ICAR and its institutes do not consider candidate if they do not have 4 years Forestry Degree.

For teaching Forestry at undergraduate and postgraduate level 4 years degree and specialization at M.Sc. and Ph.D. level is must. Keeping this in view BOs members unanimously recommend that:

1. Change qualification for Assistant Professor in Forestry as B.Sc. 4 year's degree+ 2 years M.Sc. degree (specialization in required field) with NET/Ph.D. For Associate Professor and Professor besides above Degree the teaching experience in Forestry shall be mandatory for 8 and 10 years respectively.

2. This department is already having 4 specializations at M.Sc. level, therefore, specialization should be written/printed on M.Sc. Forestry Mark sheet /degree.

3. For proper teaching, future vacancies are advertised as per the requirement of the department. Department have following specialized teachers in its faculty and needs following specialization against the vacant post as well as after super nation of current teachers as their respective field:


