CO4. This subject will acquaint the student with organisation of the functionaries under the Code, their power and functions at various stages and the procedure according to which these powers and functions are to be exercised.

CO5. The course is aimed at driving home the students how the pre trial, trial and the subsequent process are geared up to make the administration of criminal justice effective.

#### Civil Procedure Code and Limitation Act (SOL/LL.B/C-19)

- CO1. The students will be able to understand the power and jurisdiction of Civil Courts including the concept of Res-Judicata and Res sub-judice.
- CO2. The students will be able to know the provisions regarding the Pleadings, Plaint and Written Statement, Set-off & Counter Claim under Civil Procedure.
- CO3. The students will be able to know the consequences of the Appearance and Non-Appearance of the parties before Civil Courts.
- CO4. The students will be able to know the procedural laws regarding summoning and attendance of witness, Execution of Decree, Commissions, Appeals, Review and Revision.
- CO5. The students will be able to know the provisions regarding Suits by indigent person, Temporary injunction and Interlocutory orders by Civil Courts.
- CO6. The students will be able to know the provisions regarding the Limitation Act which debars the remedy before the Civil Courts in cases of unreasonable delay by the litigants.

### Offences against Children and Juvenile Offences (SOL/LL.B/E-05)

- CO1. This elective paper helps the students to get in depth knowledge of legal status of child specifically from constitutional and international perspective.
- CO2. Develop understanding of statutory provisions related to child in different laws.
- CO3. Enhance ability to analyze and critique issues related to children vizchild labour, child marriage and child abuse.
- CO4. Develop ability to sensitize the society and to protect their rights.
- CO5. Make conceptual clarity on juvenile Delinquency, sexual abuse of children with the help of enacted laws.

# Drafting, Pleading and Conveyancing (SOL/LL.B/P-03)
