#### Answer:

a) The Indian government is indeed aware that sports facilities in central universities are inadequate. In fact, the Ministry of Youth Affairs and Sports has been working to develop sports facilities and encourage sporting talent in India. The government has also launched initiatives like the Khelo India program, which aims to promote sports and fitness across the country, including in educational institutions.

#### Government Initiatives:

- Centre of Excellence for Development of Sports (CEDS) in Universities: A program launched in 2012 to develop sports infrastructure and equipment in universities.
- Operational Guidelines for Khelo India: Guidelines that outline the utilization of sports facilities and infrastructure development in central universities and other educational institutions.

#### Challenges:

Despite these initiatives, there are challenges in developing sports infrastructure, particularly in terms of funding.
