
Correction of Papers / Subjects / Courses Filled by the Batch-2024 2nd Semester Students

The students must fill the attached form and note the following:

1. The student should first contact the respective dean office / department / campus office / college for correction of subjects in exam form.
2. It is advised that the student whose correction or addition of subject(s)/ paper(s) is to be done should be present in person.
3. Only those forms which are routed through the proper channel i.e. respective dean office / department / campus office / college shall be considered for correction.
4. It is responsibility of the student that the subjects allotted to him are correctly reflected in Admit Card and any representation in this regard shall not be entertained later.
