Instructions for the shortlisted Applicants

All the shortlisted applicants for admission in **LL.M.** Ist semester (Two-year course), academic session 2025-26, are hereby informed that they must deposit the fee (as per the prospectus) online on or before the last date for provisional admission in the course, which is from 26/08/2025 to 29/08/2025. Verification of Documents of the applicants will take place in offline mode in the Department of Law, SRT Campus, Badshahi Thaul, Tehri Garhwal, between 01/09/2025 and 03/09/2025. The applicants may come for physical verification on any working day from 10 am to 4 pm. In case any discrepancy is found later at the time of physical verification with original documents, the admission will be cancelled, and NO claim shall be entertained in this regard.

- 1. These admissions are **strictly provisional** & will be confirmed only after physical verification of all relevant/required documents at the time of admission. The applicants have to bring all the original documents at the time of seeking provisional admission.
- 2. A minimum of 50% marks in LL.B./B.A.LL.B. is required for all categories to qualify for admission in the LL.M. (two-year) course.
- 3. Applicants have to provide the original documents during physical verification of documents (High School, Inter Mark Sheets & Graduation Mark Sheet, LL.B./B.A., LL.B. Marksheets, Category Certificate- SC, ST, OBC (on Government of India Format of the preceding Financial Year), EWS (if applicable of the Financial Year 2024-25) certificate-NCC/NSS/Sports Weightage Certificate (if applicable), or any other category in which the candidate is claiming admission. UET Admit card, Score card, Registration form along with duly filled admission form of HNBGU, Aadhaar card and fee receipt (2 copies) and two (2) passport size photographs.
- 4. The applicants have to submit one set of self-attested photocopy of all the above documents and Original of Transfer Certificate (TC), Character Certificate (CC), Migration Certificate & original Police Verification (for outside Uttarakhand state applicants) and Affidavit for gap year period (if applicable) and Anti-Ragging Affidavit by the Candidate and Parent and other required documents during the physical verification process.
- 5. The applicants who do not deposit their fee online till the last date of submission of the fee will lose their right of provisional admission, and the seat will be offered to the next candidate in the waiting list. For any clarification, you may contact:
