

**Notice regarding continuation (For H.N.B. Garhwal University students)
and entry (for outside university students) in U.G. 4th Year**

Eligibility for Continuation in the U.G. 4th Year – Academic Session 2025–26

The following categories of students of HNB Garhwal University are eligible for continuation in the 4th year of the Undergraduate Programme for the academic session 2025–26:

1. Students who have passed U.G. VI Semester with 120 + 2 SSD credits

- Required Action: Submit the **online generated declaration form** to the Admission Committee for U.G. 4th Year.

2. Students who have cleared 120 credits but have 2 SSD credits pending (due/arrear)

- Required Action: Submit the following **offline declaration form** to the Admission Committee for U.G. 4th Year.

(Student Declaration for continuation in the Four-Year Undergraduate Programme (FYUP) – After completion of 3 years)

I, S/o, hereby declare that I have completed the three years of the Four-Year Undergraduate Programme (FYUP), earning 120 credits but yet to clear the additional 2 SSD credits, in the programme from College/Campus. I wish to continue the Four-Year Undergraduate Programme and will clear my SSD 2 credits arrears in the upcoming academic session(s).

3. Students who have attained a minimum of 100 credits + 2 SSD credits

- Required Action: Submit the following **offline declaration form** to the Admission Committee for U.G. 4th Year.

(Student Declaration for continuation in the Four-Year Undergraduate Programme (FYUP) – After completion of 3 years)

I, S/o, hereby declare that I have completed the three years of the Four-Year Undergraduate Programme (FYUP), earning minimum 100 credits plus additional 2 SSD credits, in the programme from College/Campus. I wish to continue the Four-Year Undergraduate Programme and will clear my remaining credit arrears in the upcoming academic session(s).

4. Students who have attained a minimum of 100 credits and also have 2 SSD credits pending (due/arrear)

- Required Action: Submit the **offline declaration form** to the Admission Committee for U.G. 4th Year.

(Student Declaration for continuation in the Four-Year Undergraduate Programme (FYUP) – After completion of 3 years)

I, S/o, hereby declare that I have completed the three years of the Four-Year Undergraduate Programme (FYUP), earning minimum 100 credits and yet to clear the 2 SSD credits, in the programme from College/Campus. I wish to continue the Four-Year Undergraduate Programme and will clear my remaining arrears and my SSD 2 credits arrears in the upcoming academic session(s).

Note: For B.Tech students, the minimum requirement is **156 credits plus an additional 2 SSD credits**. In case of arrears, a minimum of **130 credits** is required.

Note: Students who have attained a minimum of 100 credits and 130 credits (For B.Tech) or any due arrears will be eligible for admission to the 4th Year (**Honours Course**) only. Such students will **not** be eligible for admission to the 4th Year (**Honours with Research Course**) for which a **minimum CGPA of 7.5** is required in 6 semesters of U.G. programme.

Eligibility for Entry (for Outside University Students) into the U.G. 4th Year – Academic Session 2025–26

1. Students who have successfully passed the U.G. all 6 semesters and have attained a minimum of 120 credits from another recognised university and have no credit arrears.
2. Students who meet all other entry requirements as specified by the University under the provisions of Multiple entry and Multiple exits.

Note: Immediately after the declaration of the U.G. 6th semester results, the University campuses and affiliated colleges should commence admissions to the 4th year of the U.G. Programme under NEP 2020 and notify interested students regarding the schedule for counselling and admission in the 4th Year of the U.G. programme.
