COORIGENDUM NOTIFICATION

Functions of the Committees

The Core Committee will plan and oversee all awareness programmes, campaigns, rallies, workshops, seminars, and outreach activities under NMBA across all campuses. It will coordinate with the UGC, Ministry, District Administration, and other stakeholders for smooth implementation and effective reporting. The Hostel and Campus Committees will monitor and supervise all anti-drug and awareness activities

The **Hostel and Campus Committees** will monitor and supervise all anti-drug and awareness activities within hostels and campus premises. They will remain in close interaction with students, ensure preventive measures are followed, and regularly report to the Chief Proctor and Chief Hostel Warden. They will also maintain coordination with local police for vigilance and safety.

The **Anti-Drug Counselling Committee** will provide counselling and guidance to students in need of support. It will organize group and individual counselling sessions, spread awareness about harmful effects of substance abuse, and refer serious cases to professional counsellors, hospitals, or rehabilitation centres. Its focus will be to create a supportive environment for students.

Note for Other Campuses

The **Directors of Pauri Campus and Tehri Campus** are hereby authorized to constitute similar *Nasha Mukt Bharat Abhiyan / Anti-Drug Committees* for their respective campuses, in line with these guidelines, to ensure uniform implementation of the programme across the University.
