In pursuance to above referred OMs, the process of carrying out Third Party Audit exercise for the year 2025-26 on CIC's portal (<https://dsscic.nic.in/users/pn-login>) has now been started. The timelines for the said audit exercise are as under: -

- i. The last date for submitting self-appraisal by Public Authorities/ mapping with Training Institute on CIC's portal (<https://dsscic.nic.in/users/pn-login>): **25.05.2026**.
- ii. The last date to get the self-appraisal audited by third party (Training Institute) and submit the audited report on CIC's portal (<https://dsscic.nic.in/users/pn-login>): **20.06.2026**.
- iii. The last date for offering the advice/ recommendations by the Central Information Commission on the above audited reports: **30.06.2026**.

2. Further, the PAs may please refer para 6.1 of the OM at reference-2 above, wherein, the Ministries/Departments have been directed for mandatory inclusion of details about compliance with proactive disclosure guidelines in the relevant chapter in Annual Report. Accordingly, in view of the timelines for laying of the Annual Reports on the Table of the House, all the PAs are requested to complete the process of carrying out audit exercise as per the above timelines on CIC's portal. The Third-Party audit will be based through digital mode on CIC's portal only and **no physical report will be accepted by the Commission.**
