Information Regarding Admission in LL.B. 1st Semester
Instructions for the Shortlisted Applicants

All the shortlisted applicants whose names are reflecting in the merit list appended with this notice (who had appeared for counselling) for admission in LL.B. 1st Semester (Three-year course), Academic Session 2026-27, are hereby informed that they must deposit their fee (as per prospectus) online on or before the last date for provisional admission in the course, which is from **19/08/2026 (5:00 p.m.) to 21/08/2026 (23:55 p.m.)**.

Verification of documents of the applicants who have submitted their fee will take place in offline mode in the Department of Law, B.G.R. Campus, Pauri (Garhwal) from **22/08/2026 and 24/08/2026**. The applicants are required to come for physical verification between **10:00 a.m. to 3:00 p.m.** on the working days. In case any discrepancy is found later at the time of physical verification with original documents, the admission will be cancelled, and no claim shall be entertained in this regard.

1. These admissions are strictly provisional and will be confirmed only after physical verification of all relevant/required documents at the time of admission. The applicants have to bring all the original documents at the time of seeking provisional admission.
2. Applicants have to provide the original documents during physical verification of documents, namely: High School and Intermediate Mark Sheets, Graduation Mark Sheets of all semesters, Category Certificate – SC/ST/OBC (on Government of India format), EWS Certificate (The OBC and EWS certificates must have been issued after 31 March 2026 and must be in the prescribed Central Government format), NCC/NSS/Sports Weightage Certificate (if applicable), or any other category in which the candidate is claiming admission. UET Admit Card, Score Card, Registration Form along with **duly filled Admission Form of HNBSGU (which can be downloaded from the University website)**, Aadhaar Card, fee receipt (2 copies of the fee deposited online), and two (6) passport-size photographs.
3. The applicants have to submit one set of self-attested photocopies of all the above documents and originals of **Transfer Certificate (TC), Character Certificate (CC), Migration Certificate**, original **Police Verification** (for outside Uttarakhand state applicants), Affidavit for gap year period (if applicable), Anti-Ragging Affidavit by the Candidate and Parent, and other required documents during the physical verification process.
4. The applicants who do not deposit their fee online till the last date of submission of fee will lose their right to provisional admission and the seat will be awarded to the next candidate in the waiting list. No claim will be entertained in this regard later on.
