Candidates must be physically present for the verification process. No verification shall be carried out in the absence of the applicant. After successful verification of documents, candidates shall be required to deposit the prescribed admission fee of **₹3,075** through the **Samarth Admission Portal** within the stipulated time. Admission shall be confirmed only after successful verification of the documents and payment of the prescribed fee.

- PG Registration/Application form with UET Score Card (Photo Copy)
- Original Transfer Certificate, Migration Certificate, and Character Certificate (Latest by 6 Month)
- OBC (NCL), SC, and ST Category Certificate (in the format prescribed by the Central Government-Photo Copy)
- Economically Weaker Section (EWS) Certificate (Photo Copy) **issued during 2026-27**.
- NCC/NSS Certificate (Photo Copy)/ Aadhar Card
- Anti Ragging Affidavit (https://antiragging.in/affidavit_registration_disclaimer.html)

Note: If the student gives any wrong information in their admission form and attached certificates are found to be false, then his/her admission will be treated automatically cancelled. All the admissions are **deemed to be provisional** before the physical verification of the documents.
